It's outage and turnaround time! We are extremely busy now on all fronts. As a reminder to everyone, there are a lot of new Apprentices on these jobs. Please look out for them and teach them the Boilermaker way. Max and I just returned from the CSO conference. There was nothing earth shattering. The push is for more manhours and members along with organizing. The Boilermakers did 26.1 million manhours last year. The Annuity for 2024 had an 8.9% return. The Pension is still doing good at 77.5% funded for 2024. No changes to the pension. Our health and welfare fund is in excellent shape. I was asked to remind members to READ THE MAIL YOU RECEIVE FROM THE FUNDS OFFICE! There is a lot of important information sent to you regarding our funds.

MOST will not be testing for THC for their annual drug test to be able to be on the BDS. This is for MOST only. However, Contractors can/will still have a zero-tolerance policy and test for THC in their pre-employment drug tests.

The Earned Sick and Safe Time pay rate in Minnesota has increased to \$1.00 per hour. This is only for work performed in Minnesota. Please take time to look at your paystub and make sure that the deductions that are being taken out are the proper amount. We have had an issue with a couple of contractors deducting the wrong amount.
