MCL is now the National Coalition of Labor. Open enrollment has been extended through January 31, 2025. Short term disability is now available, so I highly recommend that you take a look at your insurance needs for your family.

Just a reminder that as of July 5th, MOST will not be testing for THC for their annual drug test to be able to be on the BDS. This is for MOST only. Contractors can/will still have a zero-tolerance policy and test for THC in their pre-employment drug tests.
